IN THIS MOU THE PARTIES THERE TO AGREE AS FOLLOWS**







1. In accordance to NEP-2020, the skill upliftment-based courses will be offered by BioEra Organics LLP, Nashik, to UG and PG students of Microbiology, Biotechnology, Biochemistry and Chemistry, etc. science courses. BioEra Organics LLP will charge minimum possible (considering consumables) fees for such skill upliftment courses. In case if number of students will be more to be opt for these skill upliftment courses, the lecture sessions will be conducted by expertise from BioEra Organics LLP at Pratap College, Amalner (Autonomous) and practical sessions will be performed at BioEra Organics LLP, Nashik.
2. The research work carried out during the internship program, if in case processed or considered for the publication in scientific journals, the same will be published jointly by both parties and correspondence by research work place i.e. BioEra Organics LLP, Nashik, SWH-6, Baphana Warehousing Pvt Ltd., Gat No. 102/103, Ambe Hill, Mumbai-Agra Highway, Jaulke-Dindori, Nashik – 422 206, Maharashtra, India..
3. The trainee agrees that he or she will faithfully and to the best of their ability to carry out the duties and responsibilities communicated to them by the Second party. The trainee shall comply with all company policies, rules and procedures.
4. As an intern, it is the duty of the intern students to perform all essential job functions and duties mutually assigned by the First and Second party. From time to time, the Second party may also add other duties within the reasonable scope of the intern's work.

5. Students will be mentored by respective supervisors from both parties, and will encourage the students to complete the internship and submit the detailed report to College /University in the form of Dissertation after the completion of internship. Guide & co-guide from the First party will also assist the students during the period of dissertation.
6. Samples exchanged between both parties shall not be transferred to any third party for research and commercial purposes.
7. The intern's may not be paid any stipend by Second party. In case the intern is retained by the Second party (post internship), then normal employment emoluments and other terms and conditions will be applicable (as per the HR policy of the Second Party). No employment's deductions are applicable during the internship period.
8. The second party is engaged in manufacturing and research in organic as well as biologicals inputs, those are safe, non-hazardous and ecofriendly. All necessary protective gears will be provided by BioEra Organics LLP but personal safety is trainee's responsibility.
9. It is the intention of both parties to form a long and mutually beneficial relationship. However, the internship program of intern may be terminated by the Second party on following grounds with only weeks' notice,
  - 1) Misbehavior, poor work performance as per monthly assessment.
  - 2) Destruction to laboratory property.
  - 3) Theft
